Teoresi Group accelerates its digital strategy: Teoresi DigiTech is launched, a new division dedicated to software, data and cloud

- *Teoresi Group completes the integration of BindingFuture, the Milan-based company acquired in 2023, and launches Teoresi DigiTech, a new division created to support clients and partners in the development of web, mobile, software and cloud solutions, while continuing to grow in strategic areas such as smart mobility, Industry 4.0, home automation and telemedicine.*
- *Among the most innovative projects of the new division are applications for industrial plant management; energy management platforms for buildings; remote control systems enabling telemedicine; cloud infrastructures for electric mobility; and e-ticketing applications.*

Digital transformation represents a strategic lever for the competitiveness of Italian companies. By 2026, ICT (Information and Communication Technology) budgets are expected to grow by 1.8% compared to the previous year, with sector growth driven mainly by small (3.3%) and medium-sized enterprises (5.2%). The main drivers are AI, data-driven solutions and cloud technologies. In particular, cloud is consolidating as an enabling infrastructure, with the Italian market exceeding **€8 billion** (a 20% increase compared to 2024).

To accelerate growth in these strategic areas, **Teoresi Group** - an international engineering company specialized in advanced technologies - has completed the integration of **BindingFuture**, acquired in 2023, and launched **Teoresi DigiTech**, a new division that brings together the Group's expertise in **software, cloud, data and digital technologies**. The goal is to support clients and partners in their **digital transformation** and to develop cloud architectures, web and mobile applications, integrated systems and data-driven platforms, with AI support.

Teoresi DigiTech enables Industry 4.0 with data analytics, AI and cloud -

The new division supports companies across multiple sectors - from manufacturing to high-tech - in their transition to Industry 4.0, integrating software development, data analytics, Artificial Intelligence, cloud and edge computing into scalable digital solutions. These solutions enable monitoring of plants and processes, improve operational continuity and increase production efficiency. Key applications include **platforms for predictive maintenance and Big Data analytics**, systems based on private 4G/5G networks for remote factory control, and **cloud and edge architectures designed to ensure security**, reliability and high performance. Teoresi DigiTech also develops human-centered interfaces and **AR/VR solutions to support operators and technicians in the field**, alongside digital manufacturing technologies and advanced prototyping.

Home automation and telemedicine for smart buildings and future cities

Teoresi DigiTech's cross-functional expertise supports the transformation of cities into **connected sustainable ecosystems focused on people's well-being**. The division develops solutions for intelligent management of buildings and infrastructures, energy control and security, connectivity of home devices and advanced digital services. The offering also includes platforms for **telemedicine, remote monitoring and e-health**, integrating medical devices, AI algorithms and advanced connectivity, as well as **sophisticated interfaces and remote-control systems** for managing devices and service infrastructures, helping create safer, more efficient and more accessible spaces.

From autonomous mobility to smart ticketing - Teoresi DigiTech's capabilities range from applications for **connected cars and onboard data management** to platforms for **autonomous driving and ADAS systems**; from **e-mobility and fleet data management**, with tools for monitoring electric vehicles, smart charging and performance analysis, to **multi-mobility and smart ticketing** solutions that integrate transport modes, services and infrastructure to simplify the urban mobility experience.

Teoresi Group has also launched **Teoresi MedTech**, the result of the Group's investments in the healthtech sector and the acquisition, in 2023, of the Bologna-based company **MediCon Ingegneria**. Finally, in 2026, Teoresi DigiTech was established as an internal division dedicated to the development and integration of digital technologies across the Group's different areas of activity.
